This privacy policy applies between you, the User of this Website, and Rubylife Care Ltd, the owner and provider of this Website. Rubylife Care Ltd takes the privacy of your information very seriously. This privacy policy applies to our use of any and all Data collected by us or provided by you in relation to your use of the Website.

Please read this privacy policy carefully.

Definitions and interpretation

1. In this privacy policy, the following definitions are used:

Data	collectively all information that you submit to Rubylife Care Ltd via the Website. This definition incorporates, where applicable, the definitions provided in the Data Protection Laws;
Cookies	a small text file placed on your computer by this Website when you visit certain parts of the Website and /or when you use certain features of the Website. Details of the cookies used by this Website are set out in the clause below (Cookies);
Data Protection Laws	any applicable law relating to the processing of personal Data, including but not limited to the GDPR, and any national implementing and supplementary laws, regulations and secondary legislation;
GDPR	the UK General Data Protection Regulation;

User or you	any third party that accesses the Website and is not either (i) employed by Rubylife Care Ltd and acting in the course of their employment or (ii) engaged as a consultant or otherwise providing services to Rubylife Care Ltd and accessing the Website in connection with the provision of such services; and

- 2. In this privacy policy, unless the context requires a different interpretation:
 - a. the singular includes the plural and vice versa;
 - b. references to sub-clauses, clauses, schedules or appendices are to sub-clauses, clauses, schedules or appendices of this privacy policy;
 - c. a reference to a person includes firms, companies, government entities, trusts and partnerships;
 - d. "including" is understood to mean "including without limitation";
 - e. reference to any statutory provision includes any modification or amendment of it;
 - f. the headings and sub-headings do not form part of this privacy policy.

Scope of this privacy policy

- 3. This privacy policy applies only to the actions of Rubylife Care Ltd and Users with respect to this Website. It does not extend to any websites that can be accessed from this Website including, but not limited to, any links we may provide to social media websites.

Data collected

Data that is given to us by you

- 7. Rubylife Care Ltd will collect your Data in a number of ways, for example:

 - **b.** when you register with us and set up an account to receive our products/services;
 - **c.** when you complete surveys that we use for research purposes (although you are not obliged to respond to them);
 - **d.** when you enter a competition or promotion through a social media channel;

 - **f.** when you use our services;
 - g. Words of Mouth and Verbal recommendations;

in each case, in accordance with this privacy policy.

Data that is received from third parties

- 8. Rubylife Care Ltd will receive Data about you from the following third parties:
 - **a.** Families, Friends, other business associates..

Data that is received from publicly available third parties sources

- 9. We will receive Data about you from the following publicly available third party sources:
 - a. Extended Families, Friends, Extended Business Associates, Members of the Public.

Data that is collected automatically

- 10. To the extent that you access the Website, we will collect your Data automatically, for example:
 - **a.** we automatically collect some information about your visit to the Website. This information helps us to make improvements to Website content and navigation, and includes your IP address, the date, times and frequency with which you access the Website and the way you use and interact with its content.
 - **b.** we will collect your Data automatically via cookies, in line with the cookie settings on your browser. For more information about cookies, and how we use them on the Website, see the section below, headed "Cookies".

Our use of Data

- 11. Any or all of the above Data may be required by us from time to time in order to provide you with the best possible service and experience when using our Website. Specifically, Data may be used by us for the following reasons:
 - **a.** internal record keeping;

 - **c.** transmission by email of marketing materials that may be of interest to you;

- 13. For the delivery of direct marketing to you via e-mail, we'll need your consent, whether via an opt-in or soft-opt-in:

Who we share Data with

16. We may share your Data with the following groups of people for the following reasons:

- a. any of our group companies or affiliates user information is shared with group or affiliates for administrative purposes, support ,regulations, processing, marketing, monitoring and compliance.;
- b. our employees, agents and/or professional advisors User information is shared with employee, agents or professionals for work purposes and support who might be working directly or indirectly with them.;
- c. third party service providers who provide services to us which require the processing of personal data to help third party service providers in receipt of any shared data to perform functions on our behalf to help ensure the website runs smoothly, send offers, newsletters;
- d. third party payment providers who process payments made over the Website to enable third party payment providers to process user payments and refunds;
- e. relevant authorities to facilitate the detection of crime, carry out investigations , to give relevant support, the collection of taxes and to carry out duties.;

in each case, in accordance with this privacy policy.

Keeping Data secure

- 17. We will use technical and organisational measures to safeguard your Data, for example:
 - a. access to your account is controlled by a password and a user name that is unique to you.
 - b. we store your Data on secure servers.
- 18. We are certified to ISO 27001. This family of standards helps us manage your Data and keep it secure.
- 19. Technical and organisational measures include measures to deal with any suspected data breach. If you suspect any misuse or loss or unauthorised access to your Data, please let us know immediately by contacting us via this e-mail address: info@rubylifecare.co.uk.
- 20. Data retention

- 22. Even if we delete your Data, it may persist on backup or archival media for legal, tax or regulatory purposes.

Your rights

- 23. You have the following rights in relation to your Data:
 - a. **Right to access** the right to request (i) copies of the information we hold about you at any time, or (ii) that we modify, update or delete such information. If we provide you with access to the information we hold about you, we will not charge you for this, unless your request is "manifestly unfounded or excessive." Where we are legally permitted to do so, we may refuse your request. If we refuse your request, we will tell you the reasons why.
 - b. **Right to correct** the right to have your Data rectified if it is inaccurate or incomplete.
 - c. **Right to erase** the right to request that we delete or remove your Data from our systems.

- 42. Unless otherwise agreed, no delay, act or omission by a party in exercising any right or remedy will be deemed a waiver of that, or any other, right or remedy.
- 43. This Agreement will be governed by and interpreted according to the law of England and Wales. All disputes arising under the Agreement will be subject to the exclusive jurisdiction of the English and Welsh courts.
